Introduction

TradeMark Africa (TMA) and Trade Catalyst Africa (TCA) has zero tolerance to Fraud, Corruption and Misconduct (including harassment) and has developed a fraud prevention policy to support a fraud, corruption and harassment free environment.



TMA has engaged KPMG to provide confidential and independent whistleblowing channels for reporting any malpractice involving TMA resources or employees. This allows TMA employees, implementing partners, suppliers and members of the public to anonymously report any unethical practices, including fraud, corruption, and misconduct.

All the whistleblowing channels are secure.



The identity of the informant using the whistleblowing services shall not be disclosed.

Whistleblowing is the term used when a person passes on information concerning wrongdoing that could include; fraud, corruption or misconduct (including harassment).



Is a whistleblower protected?



TMA is committed to a non-retaliation towards a whistleblower and there are numerous laws that protect a whistleblower. Additionally, the whistleblower identity is protected by KPMG and all reports treated as anonymous.



Protection of whistleblowers?



Any person who makes a report of reasonably held suspicions of wrongdoing (whether through the whistleblower line or otherwise) shall not be disadvantaged in any way by TMA, including suffering any punishment, penalty, or retaliation, as a result of making the report.

5 What happens when you whistleblow?



After reporting, extensive investigations are conducted to establish the facts and obtain evidence of unethical acts.

The following are the repercussions to any person(s) confirmed to have acted unethically:

TMA employees

Disciplinary action including suspension and/or termination of employment contract, recovery of misappropriated funds and legal pursuit.

Implementing partners

Suspension and/or termination of funding arrangements, recovery of misappropriated funds and legal pursuit.

Suppliers

Suspension and/or termination of contract, debarment, recovery of misappropriated funds and legal action.
